A list of all Redbones placing in the nite-hunt and bench show must be sent to the NRCA Hunt Chairman. To receive an automatic renewal for this event next year, you must send this year's report back within 10 days of the event.

Guidelines for all Special Trophies Given

by NRCA at Zone hunts and shows

1. All owners and handlers must be up to date member before hunt or show. Must show card for proof of membership.
2. Must have plus points to win any trophy.
3. Cast winner with plus points is first.
4. If no cast winner then dog with most plus points is first.
5. A dog that is withdrawn or scratched for any reason automatically receives 400 minus.
6. Nite hunt zone winners are picked from any division of the UKC hunt.
7. If two nite hunts are held the 1st and 2nd high scoring Redbone may come from either night (all red or UKC).
8. Both 1st and 2nd place zone winners are eligible to compete in zone winners cast at National Redbone Days.
9. Zone Bench Winners- each zone should send its 2 best redbones to National Redbone Days to represent their zone. Judge will select two dogs from the following to be selected as 1st and 2nd place winners (may be of the same sex or one of each):
 - a. Two Ch. male- Best of Breed
 - b. Two Ch. female- Best of Breed
 - c. Two Gr.Ch. male- Best of Breed
 - d. Two Gr. Ch. Female- Best of BreedBoth 1st and 2nd place show winners are eligible to compete at National Redbone Days (in zone winners portion of the show).
10. These rules should be posted before entry deadline.
